Budget 2020

- Club looking for further investment, in particular local investment, to help develop all areas of LCFC
- Good progress made with regards to a Stadium Naming Rights Partner.

Club Wide Succession Planning

- Club created a 'management recruitment' document two years ago for when Cowley's moved on to prepare for the future
- Compensation received from Huddersfield for DC and NC which can be used to recruit a new manager

- Club not commenting on any names/speculation
- No timeline set on this but there would be no rushing or procrastination involved in the process

Match Day Experience

- Club looking at further investment into facilities at Sincil Bank. Figure in excess of six-figures spent in the summer on general maintenance.
- More bike racks will be installed at Sincil Bank to encourage cyclists which will in turn reduce pressure on car parking
- Club looking at resolutions for persistent standing in gangways (in particular at HT and FT) and will brief stewards accordingly
- General sale ticket comms to become consistent across all social channels
- POTD at Wycombe was not allowed due to police advice and the fixture being classed as 'category A'. This is a decision of the host club/authorities. Very little LCFC can do to influence this.
