Fan related items discussed during our busy meeting included facilities for our travelling supporters at away games,, the twice rescheduled Derby County fixture, EFL ticket pricing, & future streaming of Imps games from next season.

We also enjoyed two presentations from club staff on the club's Fan Engagement Plan & branding involving a possible change for our club badge both of which represent the club's continued commitment to engaging with our fanbase & valuing the views of all supporters concerning club heritage matters.

As part of the club's Fan Led Review we have reviewed our own governance & policies during the last twelve months including our constitution, Memorandum Of Understanding with the club & democratic election process in addition to appointing our own Minutes Secretary (Jackie Atkins) & two Vice Chairs (Marcus Burton & Charlie Beeston). 4.	Presentation from Jake Langworth and Andrew Whittham (Branding)	
	<p>Presentation to debate a change of official club crest to a refreshed version of a previous design. This is currently being used as the 'alternative' landmark on the 3rd kit; in the Legends Lounge; in the tunnel and on the wall of the stadium. RT - as the badge is reminiscent of the one used in the 1980's - would this perhaps hold some negative memories for supporters? LS we recognise this concern.</p> <p>The change was discussed at the September Exco meeting and has been met very positively by FAB.</p> <p>We all agreed to move this action to the next stage of full fan consultation.</p>	
5.	Fan Engagement Plan	
	<p>DL/RN gave a presentation on the club's fan engagement plan which will be copied to FAB members for further discussion and feedback.</p> <p>LCFC have confirmed they are happy to issue a 'Golden Share' (which will be known as The Fans Share) which will be held by the RICT. Legalities to be considered but the club are in a good position and will be ready for the appointment of the independent regulator of football.</p>	DL/RN
6.	San Diego Loyals	
	<p>MB - is there any impact for LCFC following the recent information relating to San Diego Loyals folding? LS - no financial impact for the club. Landon Donavon will now have more time to focus on LCFC. There has only ever been a partnership to mutually grow the fan base across both teams. JB - what form might Landon's input take? LS - Landon will help within the sporting side of the club, across a range of remits, if and as required, to include assistance with partnership, relationships and possible recruitment matters, should they arise.</p>	MB
7.	Streaming	
	<p>CL - is there a potential for a replacement for iFollow? LS - a TV deal by Sky has been agreed which includes the rights to the OTT (over the top) services. However details have not been confirmed. The EFL digital collective (website and streaming provision) deal expires at the end of this season and the club is currently exploring alternatives.</p>	CL

8	Fixtures Re-Scheduling	RT
	RT raised concerns regarding the Derby fixture being moved twice. LS - this was initially a request from Derby . LCFC agreed due to a sporting advantage to us both. Derby then asked to move again as there had been pushback from local stakeholders on the new date. We wish to retain the sporting advantage (not having to play Saturday-Tuesday if avoidable), so the 21 st November was reluctantly agreed.	LS
9.	Away facilities	CB
	CB asked if issues relating to the absence of facilities for less abled supporters at away grounds (such as our recent visit to Bristol Rovers) are being recognised by the EFL? LS - We have been approached for our opinion. The new EFL deal will have mandated income to help with the infrastructure of clubs who are falling below the recommended standards.	LS
10	Potential structure change to the FA Cup	RT
	RT asked if potential changes to the FA cup will have an effect on LCFC and the EFL? LS - will present more information when it is available. There will be changes but these are yet to be finalised. For EFL teams, commercially the position is improved. LS to update on progress at the next FAB meeting.	
11	Playing kits - design	TS
	In the past, the FAB (formerly Supporters Board) have been involved in the process - is there a potential for this to happen again? LS – This is becoming increasingly difficult due to the timescales involved. On this occasion, the club has sought alternative means of obtaining fan input.

12	Ticket Prices	TS
	<p>TS asked if there had been any discussions within the EFL regarding price capping? LS - confirmed that currently there is not very much support from EFL clubs for price capping. Cost of running club has risen by 18.5% whereas tickets were only increased by 5%. Regarding away games? LS - progress on this is likely once a regulator is appointed, but it will be slow progress as there will be other priorities ahead of prices.</p>	
13	Any other Business	
	<p>CB - Football Disorder. Widely recognised there was a sharp rise in disorder following lockdown. LCFC have not seen the same spike as other clubs have seen. Lincoln City are considered safe. SK - do we still have the high risk rating? LS - Some away forces are applying their strategy based on outdated data and that impacts on their decisions.</p> <p>AH - Operating costs. Should LCFC be looking to cut costs? LS - we have tried to cut costs in areas that can be cut, but to deliver to our high standard in all areas for our supporters - LCFC would need to continue as we are. Further cuts would be detrimental to the club. DL - investors are fully aware of what will be asked of them and this is monitored closely.</p> <p>JC - Congestion at the West Ham game. LS - all gates were open.
